## Funding Update ●

### > The Big Lottery Fund

Big Lottery Fund Community Building Village halls and other local venues will benefit from the new Community Buildings programme announced by the Big Lottery Fund. The programme will be open for business by summer 2006.

The Big Lottery Fund will make £50 million available over three years through the Community Buildings programme to projects across England. More details about the scheme, including information about those who can apply and how will be released in 2006.

Community buildings act as a focal point for the community and are key to promoting community cohesion. There is an established need for more and better community-owned venues that complement state-owned facilities, such as libraries and extended schools. Creating or improving community buildings such as village halls will enable local people to make better use of facilities and encourage more activities to take place within them. Although money for capital projects is currently available through existing funding streams, the Community Buildings programme will focus solely on this aspect of civil renewal. Village halls and other community venues support a diverse range of activities. When they are well run and maintained, more local people are encouraged to become involved in those activities.

Once a community building has been improved, beneficiaries could include groups and projects who need space for public meetings, parent and toddler groups, fitness, recreation, arts, basic skills training, social events and more. Whilst this programme will inevitably focus on the capital aspects of community buildings, it will be the activities that take place within each building that are crucial and fundamental to its success.

The Big Lottery Fund are working with key partners to develop the programme and are in early discussions, but they expect that the programme will focus on ensuring that there is good community engagement in developing and refurbishing these buildings. In addition, they want to ensure good community use and encourage best practice in terms of management of the buildings. Historically, both the Millennium Commission and the Community Fund provided a significant level of funding for community buildings; the Millennium Commission contributed £50 million in the form of a dedicated programme, while the Community Fund has awarded over £138 million to community buildings since 1995. ### > National Institute for Mental Health in England Community Engagement Programme 2005/6

Grants Of Up To £20,000 Available For Black and Minority Ethnic Community Groups and Organisations. Delivering Race Equality (DRE) in Mental Health Care is a five years action plan for achieving equality and tackling discrimination in mental health services in England. It is designed to deliver on three key aims: Equality of access; Equality of experience; Equality of outcomes. One of the key deliverables of the action plan is a programme of community engagement with Black and minority ethnic communities to ensure that they have genuine opportunities to influence mental health policy and provision, and to promote mental health and recovery.

This programme of community engagement will: Help to build capacity in the non-statutory sector; Encourage the engagement of Black and minority ethnic communities in the commissioning process; Ensure a better understanding by the statutory sector of the innovative approaches that are used in the non-statutory sector; Involve Black and minority ethnic communities in identifying needs and in the design and delivery of more appropriate, effective and responsive services; Ensure greater community participation in, and ownership of, mental health services; Allow local populations to influence the way services are planned and delivered; Contribute to workforce development, and specifically the recruitment of 500 Community Development Workers. The programme is being managed and supported on behalf of NIMHE, which is part of the

Care Services Improvement Partnership (CSIP) by the Centre for Ethnicity and Health at the University of Central Lancashire. We are seeking applications from Black and minority ethnic community groups and organizations who wish to participate in the programme. Preference will be given to community groups and organisations located within the boundaries of the following Strategic Health Authorities (NIMHE's Focused Implementation Sites).

The Strategic Health Authorities are:

Northumberland, Tyne & Wear; West Yorkshire; County Durham & Tees Valley; South Yorkshire; Leicestershire, Northamptonshire & Rutland; Trent; Bedfordshire & Hertfordshire; South East; London; North East London; North Central London; North West London; Hampshire & Isle of Wight; Surrey & Sussex; South West Peninsula; Dorset & Somerset; Birmingham & the Black Country; Greater Manchester. Applications are invited from organisations who wish to conduct a piece of research around the issues relating to mental health for Black and minority ethnic communities. Successful projects will actively engage Black and minority ethnic communities (including mental health service users) in the process, both as researchers and respondents. Funding will not be made available for groups or organisations to set up a new service. The closing date for completed application forms is 16 December 2005. Groups will be interviewed and selected in January 2006, and should be ready to start in March 2006. The work must be completed by December 2006.

## > Comic Relief -UK programme

Over the next four years Comic Relief are going to be working a bit differently. They want to further focus their energies and the money they have, so they can make an even greater difference to the lives of particular groups of people they think really need their support. This means having fewer grants programmes, and it also means they're going to put their weight behind these by joining forces with others to really tackle the root causes of the problem so they can help bring about lasting change. Of course, they'll continue to fund lots of brilliant projects all over the UK and are really looking forward to working with a wide range of organisations in the years ahead - some new, as well as some that they already know - but all of whom will share their passion for supporting people whose lives are really tough, and helping them to find better times. Red Nose Day programmes 2005-08 - This is their biggest grants fund. It awards some of the money raised from Red Nose Day. During 2005-08 they are concentrating their funding on 6 programme areas: Young people; Older People; Mental Health; Refugees & Asylum Seekers; Domestic Violence; Disadvantaged Communities

They can give grants for running costs and capital costs, depending on the programme you are applying to. There is no maximum grant size and the amount you ask for should be the amount you need. They are likely to make some large grants, and a range of smaller grants of between £15,000 and £30,000 each year. They also have a fast-track application process for small grants up to £5000. If you want to apply for more than £100,000 in total, please phone them before you apply. They usually make grants for between one and three years. In some circumstances, and where they are supporting projects that aim to bring about lasting change, they may consider longer-term funding of up to five years. Please talk to them before you apply for five years funding. Timetable for main grants over £5000 - There will be four grant-making cycles for 2005-2006.

Cycle Application deadline for grants over £5000: Cycle 2 13 January 2006; Cycle 3 5 May 2006; Cycle 4 8 September 2006 You should have a decision within five months of each application deadline. There is no need to rush your application. They will make sure they have funding available for every cycle. They will announce the deadlines for funding cycles in 2007-2008 towards the end of 2006. Remember, you can apply for a small grant at any time. They are likely to close all these grant programmes in 2008 and will give plenty of notice about the exact dates on their website.

Sport Relief grants - In the UK, Sport Relief aims to support projects that use sport and exercise to strengthen communities and provide opportunities for people who are excluded or disadvantaged. Over the next two years, up to £4million of Sport Relief money is being distributed through Community Foundations focusing on community groups that are using sport to: increase access to sport and exercise for people who face social exclusion and isolation; help people who are experiencing difficulties in their lives to regain their confidence and self esteem; and encourage people to take part in sporting activities that bring communities together.

### > **Online fundraising service tops £1 million**

Over £1 million has been donated to charities online through CAF's Tailored Efundraising service. Launched in August 2002, Efundraising enables charities of all sizes to accept secure, tax-effective credit/debit card and Direct Debit donations from their own website, without the need for a specialised trading and banking service.

Currently used by over 350 non-profit organisations, individual donations through the service have ranged from £5 to £10,000 and have been made from 100 countries including Australia, Belgium, the US, Canada and Japan.

Efundraising links a charity's website to secure donation pages which can be tailored to fit in with the look and feel of its own site. Working alongside World Pay, the leading e-commerce solutions company, CAF (Charities Aid Foundation) undertakes all the administration on behalf of the charity, from designing the donation pages, to processing gifts and reclaiming tax from the Inland Revenue. On average 76% of donations through Efundraising are made via Gift Aid compared to a sector average of 28%.

As well as UK sterling, charities can appeal for gifts in US dollars or Euros with further currencies added to their donation pages on request.

Charities are able to view statements of donations online, while CAF provides donor records and hard copy reports to further support their fundraising activities. In addition, charities are able to view donations being made through their websites in real time and a unique online tracking facility enables them to identify from which sites or emails their donations have originated.
